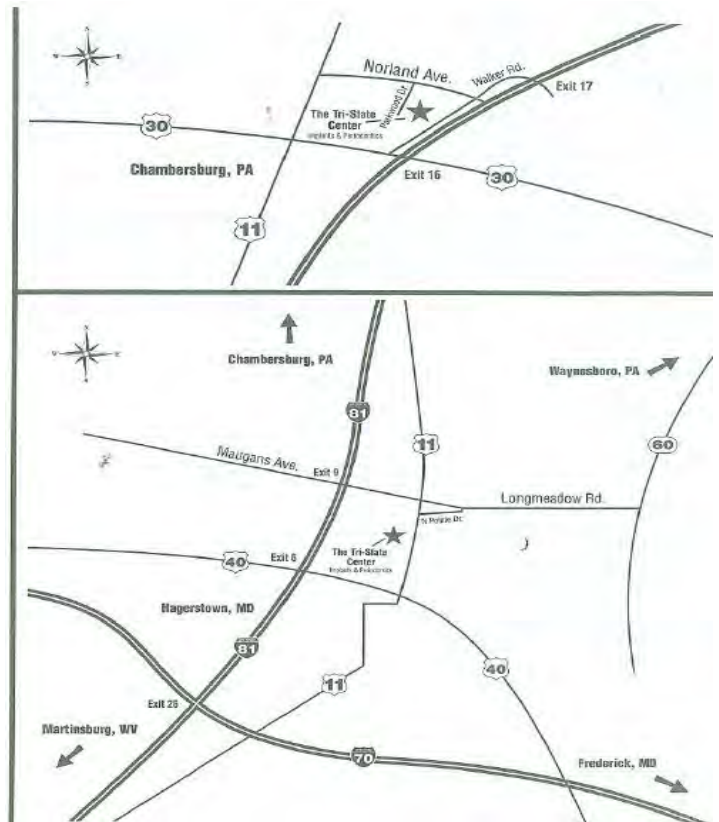
WELCOME TO OUR PRACTICE!
